- 5. The personal data provided here will be stored securely in ISD's databases and the Garda National Immigration Bureau's databases. It may be shared, if necessary, with the following third parties:
 - 5.1. Government Departments and Agencies;
 - 5.2. An Garda Síochána;
 - 5.3. EEA competent authorities;
 - 5.4. EEA police forces;
 - 5.5. 3rd parties such as employers and landlords who, with the consent of the data subject, have provided documentary evidence on behalf of an application, or such 3rd parties who have provided documentary evidence by the application.
 - 5.6. 3rd party service providers in the areas of data handling and storage and in the production of IRP cards.
