Application for permission to remain in the State under the Türkiye Association Agreement

This application form is for Turkish nationals who have been legally employed with the <u>same employer</u> in Ireland for at least 12 months. It is also for Turkish nationals who have worked for the same employer for three years.

You should use the application form if:

- You are in Ireland and have an IRP card showing your immigration Status
- You have worked legally for the same employer for at least 12 months.
- You have not been convicted of any serious crimes.

How to complete this form:

- Read the guidelines on our website <u>Türkiye Association Agreement Immigration Service Delivery (irishimmigration.ie)</u> Compete all sections of the form fully
- · Compete the form in English, in block capitals, and use ticks where appropriate.
- You must supply documentary evidence of your legal employment in the State e.g. Revenue records and letter from employer.
- Sign and date the data privacy statement
- Include the required documents listed in the checklist in Section 3.
- Do not include a copy of the Türkiye Association Agreement
- Please do not include any extra documents. If required we will ask you for other documentation.
