Application for permission to apply for a new Employment Permit

This application for is for people who have held an Employment Permit issued by the Department of Enterprise Trade & Employment but who have lost their job. This permission allows you time in the State to apply for a new Employment permit You should use the application form if:

- You entered Ireland with an Employment Permit and you have lost your job
- You have not been convicted of any serious crimes.

How to complete this form:

- Read the guidelines on our website Reactivation Employment Permit Scheme Immigration Service Delivery (irishimmigration.ie)
- Compete all sections of the form fully
- Compete the form in English, in block capitals, and use ticks where appropriate.
- You must supply copy of your current or latest employment permit, copy of the biodata page of your passport, copy of your entry stamp in your passport and a letter from DETE or your employer outlining why your current employment has ceased
- Sign and date the data privacy statement
- Please do not include any extra documents. If required we will ask you for other documentation.
