Application for Immigration Permission for a Family Dependent

This form is for non-EEA nationals who are the dependent of a family member resident in Ireland.

- A family dependent should complete this form if applying for permission to remain in the State on the basis of Family Dependency of an Irish National or legal resident in Ireland on a Stamp 1, 4 or 5 (the Sponsor) as set out in Policy Document on Non-EEA Family Reunification.
- You should complete this form if you are a person who is unable to register with the Garda National Immigration Bureau as the family dependent of an Irish National or legal resident on stamp 1, 4 or 5.
- You should not complete this form if applying for residence under EU Treaty Rights. Please check the Irish Immigration website for the appropriate EU form: <u>EU Treaty Rights</u>.

To be eligible to apply for Family Dependent Permission, you must meet the following criteria:

- The Family Dependent and the Sponsor must be in the State when the application is made.
- The Family Dependent and the Sponsor must be residing together in the same household prior to submitting the application.
- The Sponsor must be legal in the State.
- If you require a visa to travel to Ireland you must have been granted an Irish D-Join Family visa before coming to Ireland.
- You must be the dependent family member of a sponsor, that is, an Irish national; a person married to an Irish national; or a person living in Ireland with a Stamp 1, 4 or 5.
- Your family member/sponsor must be able to support themselves and any dependents without any help from public funds.
- You must have entered Ireland legally.
- You must be a person of good character
- You must be a person who has and will continue to obey Irish laws.

You are not eligible to apply for Family Dependent Permission, if:

- You are making an application from outside of the State.
- Your family member is the holder of a Stamp 2 or Stamp 3 Irish Residence permission, they do not qualify as sponsors
- You are the subject of a notification of intention to deport (15 day letter under Section 3 of the 1999 Immigration Act) or a Deportation Order or any other requirement to leave the State
- You are unlawfully present in the State at the time of making the application.

If you make an application and are not eligible, your application will not be accepted.

How to complete this form:

- Do not submit the application form without ensuring that you are eligible for the scheme.
- Compete the form in English, in block capitals, and use ticks where appropriate.
- Only one application per application form.
- All sections must be completed as required. (If a question does not apply put N/A as your answer)
- Please note that certain documents are required to be submitted with this form. Please refer to the checklist in Section 6. If any documents/information is missing or if the form is not fully completed, your application may be not be accepted.
- If you are presently unable to provide any of the information or details requested in any of the relevant sections, please explain the reasons in Section 4 of application form.
- Include the required documents listed in the checklist in Section 5. If submitting an application by post please submit photocopies of documents unless otherwise requested. <u>Do not submit</u> <u>folders, bound documents or stapled documents.</u>
- Sign and date the data privacy statement.

- The granting of permission based on Family Dependency does not entitle any other person/family member to enter or reside in the State.
- As part of the application process, DNA evidence may be requested.

If successful a *registration fee of €300 per adult* shall be payable at your local immigration office.
