Please be aware that the Irish visa fee is an administrative fee which covers the cost of processing your application. It will not be refunded if your application is refused or withdrawn.

The Fees For A Visa Are

Single Entry:	€60.00
Multiple Entry:	€100.00
Transit:	€25.00

For customers who are required to submit their documentation at a Visa Application Centre (VAC), you may also be required to pay separate service charges. Please refer to your AVATS summary sheet at the end of the visa application process for further details.

Visa Fee Exemptions

If you believe you are exempt from the requirement to pay a visa fee, then please check the box below and select the appropriate reason for the exemption based on your circumstances. Important

You should also be aware that if you incorrectly state that you are exempt from the requirement to pay a visa fee, but it later emerges that you should have paid a visa fee, your application will be withdrawn and you will need to make a new application. This will have a significant impact on your travel plans so it is important that great care is taken when claiming a visa exemption.
