OR


3. You have been refused registration as the spouse of an Irish National

- Information about your character or conduct, including convictions

- Your permission has expired and you were refused further renewal, or
- You are an asylum seeker, or
- You have been refused registration as the Spouse of an Irish National.



- You can submit your application, with all the required documentation, for through the dedicated [Customer Servi](#) You can register for an account or log in to your existing account.
- Further documentation may be requested from you if required. Requests will be issued to your email corresponde
- Select 'Submit Query' and choose the correct options from the following categories:
- 'Domestic Residence and Permissions>Submit an application> Family Dependant application
- Please attach your signed and fully completed application form in PDF format.

You may use a solicitor, legal representative or non-government agency to help you apply. However, you must write to I consent for them to act on your behalf.


